The primary objective of Northern Rock Foundation is to help improve the conditions of those disadvantaged in society. We support causes in Cumbria, Northumberland, Tyne and Wear, Durham and Teesside.

Northern Rock Foundation is an independent grant-making organisation. We were formed in 1997, when Northern Rock Building Society converted to a plc. We receive, by covenant, 5% of Northern Rock plc's pre-tax profits each year. The Foundation is fully independent of Northern Rock plc and our own Board of Trustees determines our policies.

#### Chairman's statement

2003 marked a fresh start for Northern Rock Foundation in more ways than one: new grant programmes, and a new home. Our move to the Old Chapel has given us space and a warm working atmosphere in keeping with the kind of organisation we want to be. Visitors enjoy the airy quality, the artwork and the design.

The Trustees were keen from the beginning that our new Boardroom should not languish unused between their meetings, so they decided to make it available for occasional use during the year.

We believe that lending our facilities is another way in which we can help organisations, and we are pleased that numerous regional and even national organisations have been able to use the room. We were also pleased to be asked to open the building for National Architecture Week when it was much admired, and even more delighted that it was 'commended finalist' in the accessibility category of the Lord Mayor's Design Awards 2003.

Since the business of our sole benefactor
Northern Rock plc has prospered year on year,
we have been able continuously to increase
our grants budget from an initial £5.8 million
in 1998 to a glorious £19 million in 2003.
However, not all our financial news has been
good. In common with every other prudent
charity we annually set aside a sum towards
building a reserve sufficient to iron out any

peaks and troughs in the future. As many endowed charities have reported over the past four years, investments have suffered in the stock market so that it has been difficult to maintain the level of reserve we think essential. Nonetheless, through the careful management of our Investment Committee and their determination to stick to our reserve policy, we have retained the sums we believe necessary to ensure smooth running whatever the circumstances. Happily we have not and do not anticipate the need to dip into these savings.

We have also had a second "investment pot"; three years ago Northern Rock plc, under a Share Buy Back Scheme noted in our Annual Report for 2000, purchased some of our share holding in the company. The net gain to us was £12 million. At that time my fellow Trustees with characteristic thought for the long-term decided to treat this as capital rather than income and to set it aside. Since then Northern Rock's share price has risen steadily while the value of the investment was being eroded. Consequently the Trustees decided during 2003 to spend some of the money by investing in the work of the not-for-profit sector instead of the stock market. We wanted the scale and ambition of the investments to reflect the exceptional nature of the fund. We therefore asked our staff team to come up with proposals that might make a real shift in practices or capabilities of the sector and result in visible benefits for the people we serve.

We intend initially to follow two of the suggestions our team produced. First, at 2003's final meeting we agreed to fund a substantial programme of training for organisations described on page 14 of this report and second, we decided to commit, starting from 2004, £4 million to tackling domestic violence

in the North East and Cumbria. We will use this money tactically to bring about long-term shifts in the practice of agencies currently working to help the victims of this appalling crime and to try to influence perpetrator behaviour.

This is my last report as Chairman of Northern Rock Foundation. It has been an enormous privilege to serve as a Trustee since 1997 and as Chairman since 2000. I hand over to Leo Finn who has been a fellow Trustee since the Foundation's beginning and who, indeed, as Deputy and then Managing Director of the Northern Rock Building Society, was one of those who conceived the idea of setting up such a foundation. Leo went on to become the first Chief Executive of Northern Rock plc, a post from which he retired in 2001.

As I look back on the six years of my involvement with the Foundation I feel proud of what we have achieved and grateful for the opportunity to participate in so much that has been valuable to the people of the North East. None of this could have been done by the Trustees alone. The quality and dedication of our Director and her colleagues have been fundamental to our success.

#### Director's review of the year

"A thing is interesting because of thinking about it and not because of it being new." Mark Haddon: *The Curious Incident of the Dog in the Night-time* 

For grant-makers who want an interesting life, thinking is essential. There are no new problems and not too many new solutions. Not thinking means doing the same things in the same way and getting the same results.

In 2003 we set out our new programmes, based (thoughtfully!) on our previous five years' work. We invited applicants to think more about what they were doing and why before they came to us. People who work

very hard in the not-for-profit sector tell us that they do not have much time to think; they are too busy running to stay still. We want to help them get time for reflection, review and revision. We will provide core funding for well-conceived, well-managed organisations that allows them to stop worrying and start thinking imaginatively about problem-solving ideas.

Of course, thinking alone is not enough. You have to leave the safety of old habits and try something new. Risky? Of course! The not-for-profit sector is fairly risk-averse. That is partly the fault of funders who feel they must use their funds wisely and carefully – interpreted as conservatively. We have been thinking about risk and how we can encourage more experiment among our applicants. Our first act was to create a special grant programme for it –

Exploration. We wanted people to know that they did not have to pretend to be innovative in applications to all our programmes – if they had already figured out an answer to a problem, then they could just do it. But for projects where there was some uncertainty or experiment involved, and the idea might not work, we offered Exploration grants. For these the main measure of success is that the experimenter learned something. In other words, this programme has no failure except failure to learn.

We made far fewer Exceptional grants in 2003 than previously, reflecting our determination that we would stick to the priorities set out in the new grant programmes, and that Exceptional should mean just that. However, we still need to have some flexibility at the edges of what we do, and to have a way of funding unique projects. Only four such genuinely exceptional cases came up in 2003, and there is certainly no pattern that links them. The exceptional angle is demonstrated best by our grant to Abilitynet to establish a North East and Cumbrian IT service for disabled people: a case of supporting an activity that fell outside our usual priorities, but which had strategic importance both for the client group, and for policy-making.



Our desire to understand more about what we do, and to talk more effectively about what we learn, led to the creation of a new post: Assistant Director - Policy and Communications, into which we welcomed Rob Williamson in May. We also had some goodbyes: Emma Bennewith left the administration team to become a trainee audit assistant, and our IT officer Barry Deans took up a post with Northern Rock plc's Finance Department. However, we were very pleased to welcome Susan Young on the front desk, Fran Bird who oversaw our finances whilst Alison Graham was on maternity leave, Cullagh Warnock who joined the grants team, and Sarah Gibson who took over the IT post.

You will read in our Chairman's report that we have looked carefully at how we use our resources. Both staff and Trustees share the view that we have to use or invest what we have to gain the maximum benefit for people in our area. Our loans scheme – making our money work hard, then bringing it back to work again – is taking off. In 2003 we made two loans. We are particularly grateful to Anybodycan Ltd who kindly acted as a guinea pig by patiently helping us to

work out our system. Thanks to the efforts of ABC's Philip Angier and our expert partners Charity Bank, we can now turn loan requests around quite quickly.

Finally, I want to mention Futurebuilders. We were invited, right at the end of the year, to join a Charity Bank-led consortium in delivering the Government's Futurebuilders scheme; the consortium's confirmation as winning bidders came just as our Trustees agreed to join. So we go into 2004 with an interesting new experiment to try, working with others and managing a new 'client'. Like all experiments it is fraught with "known unknowns" and "unknown unknowns". I believe that the partners are excellent and that our team here can offer considerable skills and expertise. Futurebuilders is designed to help some not-for-profit organisations develop their ability to deliver public services. On the one hand this seems controversial; on the other many of our applicants are already doing so or trying to by bidding for grants or contracts. By strengthening them we hope to make our own grant money go further and thus have more to spare for the rest.



#### **Prevention**

The causes of decline in communities and neighbourhoods are numerous, but so are the imaginative actions taken by voluntary groups to combat them. The work we fund under the Prevention programme will not change the world overnight, but it does help disadvantaged communities put in place practical solutions to

the very real problems they face.

Engaging young people who might otherwise become involved in crime, misuse drugs, or simply find themselves isolated, unskilled and unhappy is vital. East Durham Youth in Action was one of many organisations we funded in 2003 to do precisely this; we matched European funding for their programme of activities to develop skills and self-esteem. Supporting pupils excluded from school, at risk of exclusion or self-exclusion, is another growing area of work, with voluntary youth organisations playing an important role in partnership with schools. The Get Ahead Project in Blyth received a grant to help them engage with young people so they could continue their formal education and avoid drifting into anti-social behaviour. Significant

as it is for us, our investment in youth work is still a drop in the ocean compared to the need. Despite recent Government policy focus on young people, our applicants tell us that there is little new money for voluntary sector youth services. Indeed, many neighbourhood youth projects are struggling to fund their core work, a situation that is likely to worsen with the demise of the Single Regeneration Budget.





# 28 new or refurbished community buildings

In 2003 we invested over £750,000 in community centres and village and church halls. Many individual grants were small, providing new windows, kitchens and central heating –

necessities that every community facility struggles to fund. In the tiny Cumbrian village of Gamblesby, we gave £11,000 towards the capital costs of refurbishing the Community Centre using environmentally sustainable – and local – materials. In other cases we helped overstretched voluntary committees

employ staff. In the former mining village of Quaking Houses in County Durham, the village hall provides a base for IT facilities, art classes, a youth club and sport activities. Our grant meant the Village Hall Association could finally pay someone to help keep these activities going, and develop new ones.

These rural communities are dealing with the challenge of providing services for small, isolated populations; meanwhile in urban areas, community centres are finding ways of tackling some of the most concentrated social and economic disadvantage in the country. For example, in Newcastle's Pendower estate, the Good Neighbour House Project is converting a property into a new neighbourhood centre so it can expand its programme of work with children, young people, families and the community as a whole.

The guidance for our new programmes made clear that we wanted to help organisations bring about change, but that to do so they could use whatever methods were best suited to the task. Art, sport and environmental activities can all provide routes to change. In Northumberland, Pegswood Community Project received a grant to help young people through art. We awarded Wavell Wakefield Trust funding to develop a 'tag' rugby programme with young people - including young women - living in Newcastle's west end, providing them access to physical activity and helping them learn about teamwork. In Cumbria, Barrow Community Regeneration Company used their grant to deliver sporting activities aimed at involving disabled people and tackling the discrimination they face.

We also supported ideas to revive neighbourhoods through improving their

environment. Choppington
Community Association
received an award to help
realise a 'Doorstep Green' as a
place to meet and take part in
activities within the estate in
Wansbeck, Northumberland.
Improving people's health and
well-being through better diet
and fitness is also a priority
for us. Although we received

very few applications for this kind of work, we made a good start with our grant to the Great North Forest partnership to increase access to affordable, local, fresh produce to people on low incomes.

#### Regeneration

Despite 50 years of successive government initiatives and massive investment, many disadvantaged areas remain stubbornly poor. Why? The answer may be that the additional funding never reaches local economies, finding its way instead into the pockets of outside contractors or distant consultants. And the little money that does make it through cannot circulate because the local economy is failing. The Regeneration programme encourages local initiatives that address this challenge by supporting organisations that attract more money into an area, and hang on to it once it has arrived.

The region's development trusts are among a new and growing band of organisations seeking to do just this. These locally led regeneration bodies provide a dynamic vehicle enabling communities to manage initiatives at a ground level. Development trusts act as funnels, drawing funds down into communities, and as local development agencies, encouraging the growth of ground-level initiatives and enterprise.

#### 42 grants - £2.4 million

The Foundation has helped to establish new development trusts in Ashington, Hartlepool and Middlesbrough, and supported the growth of existing development trusts in Sunderland, County Durham and Northumberland.

Once money has been brought into a community it is important to stop it leaking out again. One way to do that is to set up a credit union. On Friday 15 January 2004 John Hume MP launched Wearside First – a new credit union for the City of Sunderland. John Hume is known as one of the key brokers of the Good Friday Agreement; what is less well

known is that he is also a founding member of the Derry Credit Union. Derry Credit Union began in October 1960 with initial assets of £8.50 – the contents of its founders' pockets. Forty years later it had over 20,000 members with savings in excess of £36 million.

In 1999 Liverpool John Moores University published its study *Towards Sustainable Credit Union Development*, which challenged the credit union movement in this country. It argued that to make a real difference credit unions need to have a large common bond, shop front premises, paid staff to provide services at times when people need them and financial support from a credible organisation.



The adoption of this model can be seen in the grant to Wearside First, and in those we made to Northern Oak and Newcastle City Employees Credit Union. The potential benefits these organisations can bring to the region are great. Their challenge will be to market their products as effectively on the ground as do some of the other lenders already there.

Partnerships, Employment Opportunities for People with Disabilities and Mental Health Matters are providing the help disabled people and people living with mental ill-health need to move into employment.

#### 10 development trusts supported

Traditionally the voluntary sector has tackled social rather than economic problems. Now a The Department of Trade and Industry defines this as "a business with primarily social objectives whose surpluses are reinvested for that purpose in the business or in the community." Our grants to the Shaw Trust in Middlesbrough and West Cumbria CVS will enable them to develop new social

new hybrid has emerged: the social enterprise. enterprises, providing employment opportunities for people currently outside the labour market.

These are only a few examples. Local economic renewal is a new and exciting area for the voluntary sector, and it requires an approach which many will find challenging. But in the first year of the Regeneration programme we have begun to help those organisations at the vanguard in the North East and Cumbria.

#### **Basics**

The Basics programme was greeted with relief. "Thank goodness we don't have to re-invent the wheel!" has been a comment we have heard time and again from applicants. As we say in our guidelines: 'Not every project has to be about changing circumstances; sometimes people just need more of what services or help they are already receiving.'

In an ever-changing environment for service delivery charities, we were keen to offer a stabilising element through our new funding programmes, and our investment through Basics now places us among the top 70 charitable trusts giving these kind of grants. But the demand for basic day-to-day help is enormous and we could never hope to respond to everything, so the Trustees had

to set some clear priorities.

People living with mental ill-health face severe disadvantage and prejudice. The Disability Rights Commission reports that it is

taking more cases of discrimination on the basis of mental health than any other issue.
The Government's

proposed new Mental Health Bill is controversial because it concentrates on detaining people with psychiatric disorders, rather than on supporting people to recover from or manage their condition. Recent research by the World Health Organisation indicates that depression will reach epidemic proportions by 2010. Despite this, historically mental health organisations have faced difficulties attracting funding. Through Basics we have supported



organisations offering drop-in centres, befriending services, advice and informal support. Changes North East and Eden Mind are using their grants to extend support for people living in rural areas; Mind in Gateshead is continuing to provide a high-quality service in an urban borough.

Blackwell Sailing Club offers learning disabled people the opportunity to enjoy the excitement of water sports in the Lake District. We have awarded nine grants to organisations supporting learning disabled people, all of them encouraging confidence, independence and self-advocacy. We supported Skills for People to continue its project enabling learning disabled people to understand how local government works so that their contribution to local planning committees is meaningful.

Most of our support for independent living has been to groups maintaining older people's ability to remain in their own homes. Zayis Raanon helps older Jewish women to keep in touch with their friends and their culture, and ensures that they are safe in their own homes. The Trustees awarded grants to three Age Concern branches offering benefit advice to older people. Current levels of financial exclusion undermine Government attempts to meet key social and welfare policies and so many of the grants we awarded to Citizens' Advice Bureaux have helped people claim the benefits they are entitled to, or assist people with debt problems and financial management.

It is estimated that one in four women have suffered domestic violence. Although statutory agencies and the police are working together to try to help women and children, the voluntary sector has a key role to play. Amongst our


awards were grants to refurbish a kitchen in a women's refuge, and for the salary of a worker supporting women from black and ethnic minority communities. Although refugees and asylum seekers are one of our priorities within Basics, we received only one application. The Washington Asylum Seekers Project welcomes asylum seekers to the community and supports them not only in practical ways but also in establishing friendships and celebrating their culture.

We will continue to invest in organisations adding high-quality services and assistance over and above what statutory authorities provide. Although the programme is heavily oversubscribed, the Trustees recognise that some people's needs remain constant and there will always be a place for basic support.

#### **Better Sector**

The Trustees have always recognised that to work effectively the voluntary and community sector needs a stable base, especially when so much that affects it is in flux. Before 2003 the Foundation offered community training awards, financial support for organisations that wanted to visit other projects and, in partnership with the National Council for Voluntary Organisations (NCVO), a Quality Assurance programme. The Better Sector programme builds on these activities.

In its first year we have invested most of the initial £1 million budget in the sector's infrastructure and capacity, awarding nearly £700,000 to fund staff posts at seven Councils for Voluntary Service (CVS) across the North East and Cumbria, meaning more development work, information services and funding advice. We also gave a grant to Voluntary Organisations Network North East (VONNE) to support its vital role in providing a focus and a voice for the sector in regional and national affairs.

40 grants - £3.6 million

The Trustees also wanted to increase the opportunities for training and the range of courses on offer to the voluntary sector within our area. A grant to the Directory of Social Change established the Northern Rock Foundation Training Institute, offering 10 days of management training covering strategic planning, fundraising, financial management and employment law. Nearly 150 individuals, from 47 voluntary organisations throughout the North East successfully completed the course. In the North West, the Cumbria Association of Councils for Voluntary Service, representing all the CVS in the area, received a grant to continue its programme of training and organisational development, building on its three successful years supported by the Community Fund. One of the most innovative projects funded was the Headland Development Company's accredited paralegal course covering a range of legal duties and responsibilities around company, charity, contract and property law.

The Trustees agreed to provide financial support to two organisations – the Community Regeneration Trust North East and Voluntary Action Cumbria – who wanted key personnel

to undertake a course on community enterprise, a key priority for the Foundation, at the Judge Institute of Management at the University of Cambridge. Both students will contribute 50% of the full cost of the fees and will be studying in their own time.

Two projects used the expertise of those working in the business and not-for-profit sectors to mentor and advise others. Professional support came through a 'buddying' scheme hosted by the Cumbria Community Foundation and a pro bono advisory service for voluntary organisations in Tees Valley using solicitors, accountants and architects.

they were unable to use their in-depth knowledge of working with some of the most vulnerable members of their community to sufficiently influence policy. Our grant will enable the consortium to employ an operations manager to act at a strategic

level, overseeing funding and ensuring proper two-way communication.

# £2.4 million for training and capacity building

The Foundation also supported a consortium bid from 15 small to medium organisations working in mental health in County Durham.

Pauline Pounder, who set up Headland Development Company's accredited paralegal course. At the end of the year, the Trustees decided that they wanted to do something extra to skill up the sector to keep pace with changes in legislation, funding and the increasing demands on its services. Working with Project North East (PNE), the Foundation devised a training package worth an additional £2 million, which, delivered in partnership with others, will build on existing provision and provide more personal development opportunities for staff, management committees and volunteers.

£0.8 million for infrastructure organisations

#### **Aspiration**

Most of Northern Rock Foundation's funding directly tackles disadvantage. But we feel strongly that we should also support significant arts, heritage, environmental and sporting activities and initiatives that make the region a more attractive place for everyone to live and work in. Doing so helps to build the profile of the North East and Cumbria nationally and internationally, and makes it more attractive to new businesses, thereby contributing to economic growth.

In 2003 through Aspiration grants the Foundation helped to develop the region's cultural treasures, support its artists and bring to life ambitious and exciting creative

projects. Early in 2003 the Trustees made an award to English Heritage for 'Fashion at Belsay', where top British fashion

designers will create installations within the historic surroundings of Belsay Hall,

Northumberland. The event opens to the public in May 2004, and includes works by Stella McCartney, Jean Muir, Paul Smith and Zandra Rhodes. It has already been listed in the Guardian's '100 things you must see in 2004'.

Our grant of £53,400 to the Wordsworth Trust in Cumbria towards its exhibition programme will enable it to showcase key Wordsworth treasures. We awarded Dodgy Clutch £90,000 over three years to support a creative team to

plan large-scale events in the North East, the first of which was a major outdoor performance at Alnwick Garden. The Samling Foundation

received £150,000 over three years towards its core costs, supporting a high-profile programme of music and visual arts projects across the region: 'Paint the Samling' will engage a world-class painter to work with a team of young regional artists; the Samling Opera and Contemporary Music Programme will be a partnership with the Sage Gateshead. And balletLORENT, one of the most successful dance companies resident in the North East of England, was awarded £80,000 to develop its work in the next two years, increasing its profile both regionally and nationally.

We also supported unique events within the region that celebrated its heritage and cultural diversity, including the Lake District Summer Music Festival, the Chinese New Year Celebrations, Newcastle Community Green

Festival and Whitley Bay Jazz Festival.

# £0.6 million for heritage and environmental schemes

Trustees recognise that in some cases it is worth investing larger amounts, and over longer periods to ensure that

important work fulfils its potential. Amber Film and Photography Collective received £500,000 to develop a five-year programme of film and video production and distribution, working with communities in the North East. Bede's World

was awarded £216,000 over three years to help meet the costs of achieving World Heritage Site status. And we offered £315,500 over seven years to allow the Northern Centre for Cancer Treatment to establish a permanent arts project as part of its treatment programme, building on a pilot where patients and carers worked with professional artists.

# £2 million for high quality arts projects

Investment in the region's culture reaps tangible rewards. PricewaterhouseCoopers' recent report analysing the benefits of Newcastle/Gateshead's European Capital of Culture bid found that, although the bid was unsuccessful, the bidding process had delivered real benefits, and transformed national and international perceptions, bringing a boost to the North East economy. And in late 2003 a report was published in the *Financial Times*, showing that Newcastle has in the last two years risen from 19th to 3rd in a list of the best places in the country to do business, now outranking London.

#### **Buildings to Inspire and Delight**

In 2003 the Trustees invested £2.3 million in seven projects, all demonstrating the talent and vision of cultural organisations in the North East, under our capital scheme for arts, environmental, heritage or sporting organisations. Among the new or refurbished buildings the Foundation will help realise are the world's biggest wooden tree house, a visitor centre for Britain's oldest floating warship and two nationally renowned theatres.

The Trustees considered 32 proposals under the Buildings to Inspire and Delight programme, representing a total request for over £9 million. The nine shortlisted proposals were then assessed in detail, and we sought an opinion on the architectural quality of each from the regional representative of the Commission for Architecture and the Built Environment (CABE). The Trustees agreed seven awards in July 2003.

#### 7 grants – £2.3 million

One of the most ambitious proposals was to build the world's biggest tree house in Alnwick Garden, Northumberland. We awarded £250,000 to the scheme, which will be the

next big attraction for the gardens. It will feature rope bridges, platforms and walkways, and an education suite, providing both entertainment and learning for visitors. Work began on site in November 2003 and the Tree House is on target to open in late summer 2004.

Sport is a very important part of the region's culture. Chester-le-Street Youth Development Trust will build a world-class indoor cricket facility on the riverside site in County Durham, where there will be activities and an education programme targeting young and disabled people. We awarded it a grant of £236,000; other funders include Sport England, County Durham Economic Development Partnership, County Durham LEA, Chester-le-Street District Council and the Catherine Cookson Charitable Trust. Construction was due to start in March 2004, with the aim of opening to the public in the autumn of 2004.

The region's great heritage was recognised in awards to three projects: the new museum

and visitor centre for HMS Trincomalee – one of the oldest surviving British warships – at Hartlepool's historic Quay; major repair work at the Grade 1 listed Bowes

Museum, County Durham; and redevelopment of Woodhorn Colliery in Northumberland. The Bowes Museum, which houses an outstanding collection of European fine and decorative arts, will undergo a refurbishment costing £6.5 million. In addition to our grant of £500,000, it has applied to the Heritage Lottery Fund for £4 million. English Heritage has authorised substantial funding, and several charitable trusts have awarded grants. Work should commence late in 2004, or early 2005.

# £1.1 million to improve key heritage sites

The £15.5 million redevelopment at Woodhorn will result in an eye-catching new building, due to open in 2006, to house galleries and the county records, archives and local study services, as well as improvements to the scheduled ancient monuments on the site.

We also awarded grants to two of the region's leading theatres: the Theatre Royal, Newcastle and Newcastle Playhouse. At the Playhouse, Northern Stage, the region's largest producing theatre company, is taking forward an £8 million redevelopment. Alongside our £300,000 investment, it has secured funding from Arts Council England, Newcastle City Council, ERDF and The Garfield Weston Foundation.

# £0.7 million to renovate regional theatres

The Foundation has, in previous years, helped several other prestigious cultural projects with capital grants: the Centre for the Children's Book, the Sage Gateshead, the Laing Museum and Art Gallery, Middlesbrough Museum and Art Gallery, DanceCity, Shildon Railway Museum and the University of Sunderland's Faculty of Art and Design. Since there is no shortage of ambitious proposals for cultural buildings in our area, and because funds from the National Lottery for arts, heritage and sport are decreasing, the Trustees have agreed a further cultural capital programme with £2 million available in 2004 and a further £2 million in 2005.

#### **Exploration**

Of the new grant programmes introduced in 2003, Exploration was the slowest to get off the ground. This came as no surprise: asking organisations to come up with something genuinely innovative is extremely challenging. But whilst in our other programmes we are happy to fund tried and tested projects, Exploration is different. It presents a real (and rare) opportunity for the voluntary sector to flex its creative muscles and try something genuinely new or risky.

One thing we wanted to do was fund work that made the rest of the UK sit up and take notice of the North East. The region may be the UK's poorest, but that's all the more reason for policy and decision makers to look here for evidence of the causes of and solutions to social and economic problems. Precisely this thinking was behind the Institute for Public Policy Research (IPPR), one of the country's leading think-tanks, choosing the region as its new home outside London. Our grant towards core costs, matched by the Trustees of the Millfield House Foundation, following their initial investment in developing the proposal, gives the new IPPR North an excellent start. NACRO, the national crime reduction charity, also looked to the North East as the base for research into better ways of maintaining family relationships while a family member was in prison. And our continued commitment to developing a better understanding of and responses to domestic violence means we will make further use of the invaluable North Eastbased research of Professor Marianne Hester.

assumption that because of their intellectual and social limitations learning disabled people cannot parent well. Our grant enabled it to establish a specialist project providing support through a team of volunteers to work with learning disabled parents. The work builds in evaluation from the start, and there will be a conference to share findings and launch

a "toolkit" of best practice. A grant to the University of Sunderland supported a feasibility study into an apprenticeship route for youth work, which could particularly benefit black and minority ethnic communities. And Durham Family Welfare received funding for work to explore whether a better foundation can be made between birth and adoptive parents to benefit adopted children.

Whether it's hard-nosed research or testing out a new approach, the Trustees are keen that Exploration grants are in no way detached from the rest of what we do. It must be clear how the activities we fund have a practical application that will ultimately benefit disadvantaged people in our area. As some of the work funded through Exploration starts to bear fruit in 2004, we will ensure the lessons learned are shared widely.

#### Staff Matched Giving

This year the staff of Northern Rock plc surpassed themselves, raising nearly £312,000 for local, national and international charities – over £100,000 more than in 2002. The Foundation matches every pound raised through Give As You Earn and fundraising, making the total raised in 2003 nearly £624,000, with the six-year figure approaching £1.9 million.

This year's physical exertions in the name of good causes included skydiving, cycling Coast-to-Coast, completing the Great North Run, and abseiling off a variety of North East landmarks including the Tyne Bridge, BALTIC, Centre for Life and Alnwick Castle.

Other fundraising techniques were much less sweaty, but no less hard work. They included baking a host of culinary delights that would put any celebrity chef to shame, supermarket bag-packing, and decorating 12 houses in Christmas lights. And fantastic results were seen again from the dogged determination of tombola, raffle and jumble sale organisers.

All charities greatly appreciate these efforts, but in 2003 Cancer Research UK (CRUK) came out top, receiving nearly £338,000 including the Foundation's sum. As well as benefiting from the individual fundraising efforts of many staff who have been personally affected by cancer, CRUK was Northern Rock plc's named corporate charity during the year. Credit must go to the organising team behind the company's fundraising, who led several successful events managing in the process to encourage (cajole?) staff to take part, or at least part with some money.





#### 2003 type of support







## Grant programmes and other initiatives

#### **Prevention**

Preventing local and regional social decline – actions that stop social problems from developing or worsening – concentrating on: crime, discrimination, teenage pregnancy, parenting, substance abuse, environmental decay, youth disaffection, and poor community facilities.

#### Regeneration

Local initiatives that improve the economic prospects of an area or a community of interest and ensure money stays within it: social businesses, development trusts, job creation schemes and training for work.

#### **Basics**

Basic day-to-day services over and above what statutory bodies offer. Our priorities are: mental health and learning disability; independent living and advocacy; carers; victims of domestic violence; money, debt and welfare advice; financial inclusion schemes.

#### **Exploration**

Exploration and experiment – practical research, trying out, thinking, finding new ideas or ways to address social problems, with an emphasis on learning from what works and what does not.

#### **Better Sector**

A better, stronger voluntary sector – making the sector more capable of helping itself and others, articulating its needs and fighting its corner – through supporting umbrella bodies, and by improving the quality of individual organisations' work.

#### **Aspiration**

Assistance to arts, environmental, heritage and sporting charities seeking to provide enjoyable and stimulating activities of the highest quality that raise the profile of our area and make it a better place in which to live and enjoy life.

#### Cultural capital scheme

Support for significant, ambitious and highquality proposals for new or refurbished buildings for arts, environmental, heritage or sporting organisations. We are interested in both the activities inside the building, and the quality of its design.

#### Loans

Loans can be for capital expenditure, bridging funds, working capital, the costs of developing new activities or to pay for regular commitments.

#### **Special initiatives**

In 2004 the Foundation will launch special initiatives on domestic violence and penal reform which we will run in partnership with organisations in the field.

#### Training and capacity building

The Foundation runs courses in partnership with a number of training providers. We also offer two small capacity building schemes: Community Training Awards – small grants to help organisations grow and develop, and Visit and Learn – support towards the costs of visiting similar organisations to learn from them.
